**Enrichment Program Agreement:**

I wish to have my child participate in the Heritage Learning Center Enrichment program.

I understand that:

- ◆ **Spaces may NOT be transferred to another date or another child.**
- ◆ All participants must be **potty trained.**
- ◆ All participants are required to bring a “NUT FREE” **lunch** to Enrichment.
- ◆ All participants are required to purchase a cot sheet for **\$10.**
- ◆ All participants will be required to have a 30 minute “**rest period**” during the afternoon session.

The **FIRST ENRICHMENT PAYMENT** is due by **March 1, 2018.** Placement will be CANCELLED if PAYMENT is not received. **THE FIRST TUITION PAYMENT IS NON-REFUNDABLE.**

**REMAINING TUITION PAYMENTS** are due on the first of each month, JUNE through JANUARY. Payments received after the 10th will be subject to a \$5.00 late fee.

**TUITION PAYMENTS MADE IN ADVANCE** (with the exception of the first month’s tuition) will be refunded in full provided **30 days written notice** is given prior to the date of withdrawal. **If 30 days written notice is not given to the school before the date of withdrawal then I understand I will forfeit any and all tuition paid in advance. If the child will not be attending Heritage in the fall, notice must be received by August 1, 2018.**

**\*\*I understand if I fail to make any of the enrichment payments that are due June 1, July 1, and August 1 by the 10th of the month that I will forfeit my child’s placement.\*\***
